Sub: Regarding Re-uploading of legible documents which are required by Review Committee Members.

Dear Sir,

This is to state that as required against our online application number: SL – 90025 – 2324 for secondary level affiliation we are re-uploading the legible documents which are required by Review Committee Members along with the clarification of the given remarks. All the images uploaded are in 300 dpi.

REMARKS ALONG WITH CLARIFICATION:

1. The front wall of the school is less than 6 ft of height and it is partially covered with the iron grills. Further, one side of boundary wall is not constructed; said part is covered with green tin shed. The school is required to construct the concrete boundary wall from all four sides with minimum 6 ft of height.

CLARIFICATION: The front wall of school is now of 6 ft 4 inches height and it is fully constructed "pakka" wall. On the other side the boundary wall had green tin shed, now the green tin shed has been completely removed and "pakka" boundary wall of 8 ft 6 inches height has been constructed. Now the school is covered by "pakka" Boundary Wall. (video uploaded)

2. The school has submitted land certificate measuring 12646 sq. mtrs out of which 4000 sq. mtrs of land is leased to school. However, as per the certificate, the compactness is given against of entire land area. Thus, the school is required to submit the revised land in prescribed format i.e. appendix-X measuring 4000 sq. mtrs with compactness of the said land area on which school is located.

CLARIFICATION: We are re-uploading the revised land certificate duly signed by the Tehsildar in the prescribed format clearly mentioning that the entire land area measuring 12646 sq. mtrs, out of which 4000 sq. mtrs of land is leased to school and the school is located on this 4000 sq. mtrs of land.

3. Composite Science Lab and library are under stocked. The school is required to upgrade the same as per Board's Sop.

CLARIFICATION: The school has upgraded the Composite Science Lab and Library stock. Now sufficient lab equipments and books are available in Lab and Library of the school as per Board's SOP. (Video uploaded)

4. Ramp to access upper floor is partially covered in the video, Further, The school does not have ramp at the ground level and- separate toilets (for Girls /boys) with proper permanent signage. Thus, the school is required to take the necessary action for provision for CwSN as per norms of RPwD Act and board's guidelines
(https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf.)

CLARIFICATION: Video with full coverage of ramp to access 1st floor is uploaded again. The school is submitting an affidavit stating within 03 months period, Ramp for access to Second Floor will be constructed. We would also like to mention that **school already has** Ramp at the (school entrance) Ground level. (Video uploaded). Two Ramps at two different places have been constructed to access the Play Ground. (Video uploaded)

The school already has separate toilets (for Girls /boys) on each floor with proper permanent signage and required facilities. The school has separate toilets for CWSN students. The School is submitting an affidavit stating within 03 months period the width of the CWSN toilet doors will be extended to 3ft.

5. The school is required to submit video link on its letter head covering the following point which should be in continuity
- I. Entrance of the school with main gate and complete boundary wall from all sides in continuity along with aerial view.
 - II. Complete internal view of the Library and all the labs including storage room and sitting arrangement.
 - III. Drinking water facilities of every floor
 - IV. Clear view of ramp given on ground floor and ramp/lift to access upper floors.
 - V. Separate toilets for girls and boys on every floor for CWSN
 - VI. Play area with indoor and outdoor game facilities and other infrastructure.

CLARIFICATION: The video link covering Para 5 (Point No. I to Point No. VI) is in continuity.
